 - a. <u>Purpose</u>:

FUNDACIBA (PEDECIBA) (hereinafter referred to as the Recipient), is hereby provided a federal award, the purpose of which is to:

Set up 6 stations in rural high schools in the north of the country, for students to detect fireballs and thus engage youth in STEM research projects. The stations will be part of a national network for the detection of bright meteors.

The Recipient shall carry out this award in accordance with its proposal dated March 18, 2021, and any revisions to which both parties agree to in writing. The Recipient's proposal and any subsequent negotiated revisions are hereby incorporated by reference.

b. <u>Objectives and Expected Outcomes</u>: The Recipient agrees to perform the program and meet the specific objectives below:

Consolidate a research group, strongly committed to university extension that contributes to the characterization of meteor activity at the regional level. The project has a strong component of university outreach. This is an important effort to bring science activities in a less-developed part of the country.

General objective: Involve local educational communities, with a "community-based participatory research" (CBPR) approach.

Scientific objective: Improve the detection of meteor showers in the southern sky and evaluate the impact risk of meteoroids to the Earth.

Specific objectives: i) extend the network of all-sky stations to the northern part of Uruguay, attaining the coverage of the whole country. ii) Engage a large group of highschool students and teachers in a research project in the fields of STEM.

Method: Grantee will set 6 all sky stations in public high schools located in the north of the country, for high school students to monitor for fireballs. Grantee will also train undergraduate students and high school teachers to create collaborator groups to be able to participate in the following steps of the project:

- Support the installation and basic monitoring of the correct functioning of the stations.
- Classification of the recorded videos.
- Search for meteorites in case of very bright bolide.
