

SUPPLEMENTARY AGREEMENT N°2 (JR)
to the

FIXED CONTRIBUTION CONTRACT N° CI1.0120.U (H)

between

THE EUROPEAN ECONOMIC COMMUNITY

and

UNIVERSIDAD DE LA REPUBLICA

The European Economic Community (hereinafter referred to as "The Community") represented by the Commission of the European Communities (hereinafter referred to as "the Commission") represented for the purpose of the signature of this contract by the Director General for Science, Research and Development, or its authorized representative,

of the one part,

and

The Universidad de la República (hereinafter referred to as "the Contractor"), whose principal office is situated at General Fiores 2124, Montevideo, Uruguay, represented for the purpose of the signature of this contract by Mr. Samuel Lichtensztejn, its Rector, and Professor Carlos Piriz Mac Coll, Dean of its Facultad de Química, or its authorized representative,

of the other part,

HAVING REGARD to the agreement concluded between the Community and the Contractor on 13 July 1988 with number CI1.0120.U (H), entitled "Preparation and characterization of an experimental antidiotype vaccine against *Echicococcus granulosus*" (hereinafter referred to as the Contract),

HAVING REGARD to the agreement concluded between the Community and the Contractor on 17 July 1989 with number Supplementary Agreement N°1 to the Contract (hereinafter referred to as the Supplementary Agreement N°1),

WHEREAS it is expedient to increase the financial contribution of the Commission for the Research to be executed by the Contractor,

HAVE AGREED AS FOLLOWS:

Article 1 - Execution of the Research

Article 2.2 (d), (e) and (g) of the Supplementary Agreement n°1 shall be substituted by the following:

- 2.2. (d) total estimated costs: 553,000 ECU (five hundred and fifty three thousand ecus)

- (e) financial contribution of the Commission: 216,200 ECU (two hundred and sixteen thousand two hundred ecus)
- (f) advance payment: 50,600 ECU (fifty thousand six hundred ecus)
- (g) periodic payments:
 - 50,000 ECU (fifty thousand ecus) on signature of the supplementary agreement N° 1 by both parties.
 - 38,485 ECU (thirty-eight thousand four hundred and eighty-five ecus) on receipt and approval by the Commission of the periodic report at the end of 12 months following the signature of the contract.
 - 35,595 ECU (thirty-five thousand five hundred and ninety-five ecus) on receipt and approval by the Commission of the periodic report at the end of 24 months following the signature of the contract.
 - 18,900 ECU (eighteen thousand nine hundred ecus) on signature of this Supplementary Agreement N°2 by both parties.
 - 10% on receipt and approval of the final report in its definitive form, and the report and Confidential Declaration referred to in Article 4.2 (c) of Annex I.

Article 2 - Workshop

The cost of the "International Workshop on Helminth Basic Research" shall be considered as an allowable cost under this project up to a maximum of 18,900 ECU (eighteen thousand nine hundred ecus).

Article 3 - The Research

Appendant Summary Table relating to the workshop detailed in Article 2 of this Supplementary Agreement n° 2 shall be added to Annex IV "Research" of the Contract and to the "Technical Annex" specified in "Article 2 - Research" of the Supplementary Agreement n° 1, as an integrating part of both.
