AGREEMENT

Between the University of Uruguay (School of Veterinary Medicine) and the Swedish University of Agricultural Sciences (Faculty of Veterinary Medicine)

ARTICLE I

The University of Uruguay (School of Veterinary Medicine) and the Swedish University of Agricultural Sciences (Faculty of Veterinary Medicine) agree in principle to establish formal institucional contacts which will allow their faculty members and postgraduate candidates to participate in exchange programs in the field of Veterinary Medicine, particulary in morphology, clinical chemistry, reproduction, and medicine of food producing animals. The exchanges may include: (1) the exchange of postgraduate students to pursue some parts of their studies; (2) faculty members to exchange professional views, conduct lecturing and research.

ARTICLE II

In exchange of faculty members, each university agrees to place at the disposal the facilities it normally accords visiting faculty members. Each university agrees to inform the other of its priorities in such an exchange and of faculty members interested in participation.

ARTICLE III

For exchange involving participation in degree-granting program, candidates are subject to the admission criteria of the host departments.

ARTICLE IV

In the case of affiliation for participation in non-degree granting programs of research, the research projects and applications of exchange participants will be subject to review by the host institution.

ARTICLE V

The nomination of candidates will be accompanied by information about his/her educational background, present position, teaching and research experience, research proposal, etc. Nominations of candidates for exchange can be made at any time, but not later than 3 months in advance of the begining of the visit.

ARTICLE VI

Financing of the agreement

A. Postgraduate students enrolled in degree-granting programs

Tuition and living expenses will be assumed by the organization or organizations which award scholarship or other financial assistance.

B. Faculty members

The universities recognize that accompanying costs can not always be met from the host institution. Both universities therefore agree to seek appropriate external funding to facilitate implementation of this agreement.

ARTICLE VII

This agreement is signed for 3 years, but can be modified at the request of either signatory.
