



GENERAL MEMORANDUM OF UNDERSTANDING

AN AGREEMENT BETWEEN THE UNIVERSITY OF WESTERN SYDNEY MACARTHUR, AUSTRALIA AND UNIVERSIDAD DE LA REPUBLICA, URUGUAY

1. The University of Western Sydney Macarthur and Universidad de la República desiring to develop academic exchange and cooperation in teaching and research in the furtherance of the advancement and dissemination of learning agree as follows:

- (a) to encourage, and use their best endeavours to effect visits from one university to the other by members of the academic staff for the purpose of participating in teaching and research programs;
(b) to offer admission from one university to the other to qualified students to undergraduate and graduate degree and diploma courses;
(c) to encourage the exchange of scientific materials, publications and information; to develop projects of common interest;
(e) to jointly seek both national and international financial assistance to support the objectives of this Memorandum;
(f) to prepare, as necessary, a working program detailing the form and content of each specified project. Such project programs should specify; a project director, detailed objectives, obligations and rights of the participants, sources of funding and methods to evaluate outcomes.

2. The universities acknowledge that all visits of staff and the admission of students will be subject to compliance with the entry and visa regulations of Australia and Uruguay and the universities' requirements in respect of admission and staff appointments.

3. The universities acknowledge that in the absence of any specific agreement to the contrary, all expenses of salary, travel and living and allied costs will be determined at the discretion, and be the responsibility, of the visitor's home university.

4. The universities agree to review this agreement after five years from the date hereof. It may be terminated at any time by mutual consent or by nine months' notice by either party.

However, the termination of this agreement will not normally affect the completion of projects already under way except as otherwise decided by both parties.

**Student and Staff Exchange Agreement**

An Agreement between the University of Western Sydney Macarthur and Universidad de la República, Uruguay

The University of Western Sydney Macarthur and Universidad de la República, Uruguay desiring to develop academic exchange and co-operation in teaching and research in the furtherance of the advancement and dissemination of learning agree as follows:

1. During the term of the agreement five (5) students from each university may be enrolled as full time non-degree students at the other University for a period of one semester or one year. Students participating in this program will continue as candidates for the degree of their home university. The number of participating students from each university will not exceed each other during the term of this agreement.
2. The program is open to graduate students and to undergraduate students who have completed at least one year of undergraduate study. Participating students will be selected by the home university generally on the basis of academic merit. It is understood that the host university reserves the right to reject any candidate in which case the home university may nominate additional candidates for consideration.
3. Each participating student will take courses regularly offered at the host university and will enjoy the same rights and privileges and be subject to the same regulations and discipline as students at that university. The universities will provide each other with adequate information on the performance of participating students and each university will nominate a member of staff to coordinate the program.
4. The universities agree that any incidental fees assessed against participating students under this agreement shall not be greater than those normally paid by students of the host university. Neither university shall make any charge for tuition, application or administrative purposes under this agreement.
5. The payment of housing together with the payment for all travel, medical insurance and subsistence costs shall be the responsibility of the individual students participating in the program and neither university shall be held liable for such charges. Students selected shall satisfy the home university that they have adequate funds for transportation to and from the host university and for subsistence during their enrolment at the host university.
6. Faculty visits and staff exchanges will be negotiated and administered as mutually agreed to by the departments faculties involved. The Home Institution will pay staff involved their appropriate financial remuneration. Costs of travel and medical insurance will be the responsibility of the staff involved or the Home Institution. The Host Institution will provide appropriate office/laboratory space to the visitor.
7. The agreement will commence on October 25, 1999 and continue thereafter for three years subject to revision or modification by mutual agreement. Either university may, by notice in writing of no less than six months terminate this agreement but any students who have commenced at either university at the date of termination may complete their courses of study. The universities will confer concerning the renewal of this agreement two months prior to its expiration.
