INTERNATIONAL MEMORANDUM OF UNDERSTANDING BETWEEN UNIVERSIDAD DE LA REPUBLICA, THE FACULTY OF VETERINARY SCIENCES, URUGUAY AND COLORADO STATE UNIVERSITY (CSU), FORT COLLINS, COLORADO USA

The Universidad de la República, from now on (UR), represented by its Rector, Eng. Rafael Guarga, the Faculty of Veterinary Sciences, from now on (FVS), represented by its Dean Dr. Alberto Cirio and the Colorado State Board of Agriculture by and through the Colorado State University (CSU), represented by their ~~Interim~~ Director Al Dyer, propose to further their interests in accordance with this International Memorandum of Understanding (IMOU).

ACCORDING TO

- I.- Existing cultural treaties between Uruguay and United States of America,
- II.- That in accordance with the Organic Law of the U.R., its responsibility is teaching in all the major fields of culture, as well as its development and promotion; maintain and promote scientific and technological research and artistic activities; and contribute to study problems of general interest and tend to its public comprehension.
- III.- That the activities programmed under this Agreement are financially feasible and in accordance with the policies of the ~~Council of Regents~~ ^{Board of Governors} of ~~Colorado~~ ^{Colorado} State and all other governmental authorities, and those of UR,
- IV.- Both parts wish to strengthen their efficacy in the accomplishment of their objectives by means of mutual cooperation;

They AGREE to celebrate an AGREEMENT which will be ruled by the following clauses:

FIRST: The purpose of this IMOU is to encourage voluntary interaction and cooperation and to promote friendship between the two parties for their mutual benefit.

SECOND: UR and CSU recognize the value of cooperative educational experiences that integrate theory and practice and promote campus internationalization of our respective organizations.

THIRD: UR and CSU anticipate a close relationship in order to share the benefits of their respective institutional accomplishments, to discuss the frameworks of their different educational systems, and to develop future areas of cooperation.

FOURTH: UR and CSU may encourage their respective faculty and students to pursue collaborative research that is jointly beneficial to their professional development and will lead to increased understanding between the parties and their respective countries.

FIFTH: UR and CSU encourage and welcome the exchange of short-term visiting scholars. The principal purposes of any such visits are to deliver lectures and seminars, to engage in collaborative research in areas of common interest, and to explore mutual projects and the means to support them.

SIXTH: Neither party is obligated to expend any monies or other resources in connection with this IMOU. Resources for implementation of any undertaking that may result from this IMOU may come from either party, depending upon budgetary availability. No commencement of any specific projects resulting from this IMOU may be initiated prior to the written assurance of such budgetary availability to the other party. To the extent any external funding is required by CSU for any purpose and funding for such purpose is not appropriated or otherwise made available, CSU will have no further financial obligations upon such determination.


SEVENTH: The implementation of any cooperative research project or of any proposed visit shall be conditional upon both the availability of sufficient funding acceptable to each of the participants and the execution of a written agreement therefore signed by authorized officials of the participating organizations.

EIGHTH: UR and CSU will each designate a departmental or unit home and a representative who is to be responsible for the management of this IMOU. Both parties agree to notify the other if the department/unit or representative changes in the course of the agreement, and to in turn inform their respective international and/or administrative units.


NINTH: This IMOU takes effect when signed by authorized representatives of the participating organizations. The agreement will continue in force and effect for a period of five (5) years from such date. Renewal of the agreement may be initiated at the end of each such five (5) year period, and will require signatures by authorized officials of the participating organizations.

TENTH: This agreement may be terminated at the request of either party by giving advance written notice of sixty (60) days.
