Al finalizar este período ambas partes deberán reevaluar el Programa y elegir extender o terminar el Convenio por mutuo consentimiento.

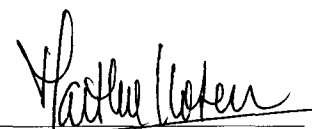
