

Cooperation agreement between

Universidad de la República - Servicio Central de Extensión y Actividades en el Medio and with the Swiss Federal Institute of Technology (ETH Zurich) - Center for Research on Architecture Society and the Built Environment (ETH CASE).

This cooperation agreement is made between: the ETH Wohnforum – ETH CASE (Centre for the Research on Architecture Society and the Built Environment) (ETH CASE), represented by its Head, Dr. Marie Glaser, with registered address at Wolfgang-Pauli-Strasse 27, 8093 Zürich and the Universidad de la República – Servicio Central de Extensión y Actividades en el Medio, represented by the Rector Rodrigo Arim Ihlenfeld and the Pro Rector of Extension, Mariana González Guyer, with registered address Av. 18 de Julio 1824, 11200 Montevideo; in relation to the completion of the research project approved and financed by the Swiss agency SNIS (Swiss Network for International Studies) and presented jointly by the teams from both countries and also considering the possibilities of complementarity between both institutions that recognize the importance of promoting their relationships, as well as the need to develop knowledge through joint and complementary research, teaching, and to maintain cultural, educational, professional and scientific ties, agree on the present agreement that will be governed by the following clauses:

FIRST: The purpose of this agreement is for the specific execution of the approved research project: *“Tackling the Global Housing Challenges Relevance and replicability of Switzerland's and Uruguay's Housing Cooperatives' policies and strategies”* through cooperation activities linked to its implementation in all its phases.

SECOND: The agreed implementation phases and tasks are the following:

THIRD: In order to respond to the proposed objectives, the ETH-Zurich will carry out the transfer of resources based on what has been agreed in the activities and intermediate products of the project in progress.

The transfer of resource will be made in the following way: first tranche of 20'763 Swiss Francs against the signing of the agreement; second tranche of 20'763 Swiss francs against delivery of progress report (approximately at the end of the first year of the agreement); third tranche of 10'381 Swiss Francs against delivery of the final project report.

FOURTH: Obligations between the parties:

The ETH Wohnforum-ETH CASE assumes the academic coordination of the project including the coordination of the team in Zurich and its main researchers, the associated researchers and the international counterpart.

UDELAR, through the Servicio Central de Extensión y Actividades en el Medio y el Área Sector Cooperativo y de Economía Social y Solidaria, is constituted as a counterpart assuming the coordination of the Uruguayan team, its main researchers and associates.

FIFTH: Both parties, by mutual agreement, may request the participation of third parties to assist in the financing, execution, coordination, monitoring of programs and projects related to this Agreement.

SIXTH: This Agreement will remain in force for 2 years, automatically renewable if neither party denounces it.
