

**RESEARCH AGREEMENT BETWEEN
DELTAVIT AND MARCO PODESTA FOUNDATION**

In the city of Montevideo, Uruguay on 8th July, 2021 the Marco Podestá Foundation of the Veterinarian Faculty - Republic University, represented by his President Dr. José Miguel Piaggio Mazzara and DELTAVIT (Reg Number 313296 550 Trade register Commercial Register of Rennes, France) represented by his Director of Development of DELTAVIT, Emilien Dupuis meet to sign this Agreement.

CONSIDERING

I. That both institutions recognize the importance of promoting the development and dissemination of culture and, in particular, the development of education; extension and scientific and technological research on topics of common interest.

II. That both institutions recognize the existence of common interested areas in which jointed work can contribute to their institutional purposes.

The parties are willing to conclude an Agreement that will be governed by the following clauses:

CLAUSE 1. DELTAVIT desires to evaluate the the effects of CCPA natural monensin alternative on dairy cows' milk production and composition (including milk fatty acid profile), rumen fermentation, energy & calcium, metabolism and the immune system and the Uruguayan researchers possesses the skills and resources necessary to carry out this Study.

CLAUSE 2. To comply with this objective, a research protocol will be designed and executed together.

CLAUSE 3. DELTAVIT is committed to provide a total amount of USD 53288 for the Study in three payments of USD 24000 to be paid upon signature of this contract, USD 17873 in January 2022 and USD 11415 to be paid upon the final report is performed by the Uruguayan researchers.

CLAUSE 4. Marco Podestá Foundation will debit 7% of the total amount of the Agreement for administration costs.

CLAUSE 5. Marco Podestá Foundation and the research team involved in the Study agrees not publish or disclose to any third party any data, documents, or records related to the Study or their results without DELTAVIT's advance written approval, which will not be unreasonably withheld.

CLAUSE 6. Marco Podestá Foundation and the research team involved in the Study recognizes that DELTAVIT is and will be the owner of the intellectual property rights of the results, reports, products and/or processes generated from the activities included in this Agreement. Anyway, DELTAVIT allows the research team to publish the data in peer-reviewed journals or in scientific meetings only after the Clause 5 is accomplished.

CLAUSE 7. For the management of this Agreement the Technical/Academic representatives from DELTAVIT will be Aline Cristina Dall Orsoletta and Marisela Arturo-Schaan and from the Veterinary Faculty will be Ana Meikle and Lourdes Adrien. This Coordination Committee will be in charge of preparing, approving and modifying the work schedule defined in the research protocol, as well as taking the technical and operational decisions related to the execution of the activities of the Study.

CLAUSE 8. Both parties, by mutual agreement, may request the participation of third parties to collaborate in the design, financing, execution, follow-up or evaluation of the Study.

CLAUSE 9. This Agreement will have a duration of two years, and will be extendable for periods of one year automatically, unless any of the parties express otherwise unequivocally. If extended, the parties will agree a new budget according to the activities planned. This Agreement may be denounced provided with three months' notice that one of the parties indicates it convincingly.

CLAUSE 10. Any difference resulting from the interpretation or application of this Agreement will be resolved through direct negotiation.

CLAUSE 11. This Agreement will begin on the date of its signature, for which purpose two copies will be issued with equally authentic texts.
