**MEMORANDUM OF UNDERSTANDING
BETWEEN SCIENCES PO TOULOUSE (FRANCE)
AND
UNIVERSIDAD DE LA REPÚBLICA (URUGUAY)**

and represented by its Rector, Rodrigo Arim Ihlenfeld, who delegates his signature for this act to the President of International Relations Service (SRI), Gonzalo Vicci Gianotti, according to resolution 24/2022 dated 17/01/22.

AGREEMENT

In accordance with a mutual desire to promote interests and in order to strengthen their cooperation and develop their exchanges, Sciences Po Toulouse and Universidad de la República have agreed to enter into the following agreement of cooperation.

Both Universidad de la República and Sciences Po Toulouse will encourage contact and cooperation between their own faculty members, departments and other affiliated institutes and programs. This agreement shall enable Universidad de la República and Sciences Po Toulouse to enter into working relationships with one another, subject to the following provisions.

1. Fields of co-operation

Cooperation between the two institutions contributes to their developing academic and cultural relations. It concerns research and education in the fields of Political Sciences, International Relations, and any other area of collaboration that the parties may agree upon in due course.

2. Aims of cooperation

- 2.1 Exchange of faculty members, graduate students and undergraduate students (subject to the terms agreed for in a specific exchange agreement) for research and study;
- 2.2 Exchange of information in fields of interest to both Sciences Po Toulouse and to Universidad de la República.
- 2.3 Development of professional and continuing education courses and programs to benefit students and faculty in Uruguay, France and, where appropriate, other countries;
- 2.4 Exchange of scholars for lectures, talks, conferences, colloquia, symposia and sharing experiences.

3. Research and teaching exchanges

The conduct of joint activities, the conditions for utilising the results achieved, and arrangements for specific visits and exchanges as well as other forms of co-operation will be negotiated for each specific case.

4. Student exchanges

An Exchange Agreement for student exchanges to be reviewed annually specifies terms and number of students.

5. Protection of personal data

Each party to the memorandum of understanding is bound to comply with the rules regarding the protection of personal data to which it has access for the purposes of performing the contract. These rules are derived from Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, and from Law No. 78-17 of 6 January 1978 on data processing, data files, and individual liberties. The parties will also be governed by Law 18.331 (Personal Data Protection Law) and Law 18.381 (Law on the Right of Access to Public Information).

6. Discrimination

It is understood that Universidad de la República and Science Po Toulouse subscribe to the principle of equal opportunity and do not discriminate on race, sex, age, ethnicity, religion, or national origin. Both Universidad de la República and Sciences Po Toulouse shall abide by these principles in the administration of this agreement and neither institution shall impose criteria for exchange of scholars or students which would violate principles of non-discrimination.

7. Results

The conduct of joint activities, the conditions for utilizing the results achieved, and arrangements for specific visits and exchanges as well as other forms of co-operation will be negotiated for each specific case.

8. Length

The present agreement will become effective for a period of 5 years from the date of signature. It will terminate when either institution gives notice in writing, at least six months prior to the expiration date.

9. Implementation

The coordinator unit in charge of implementing this agreement from Universidad de la República will be the International Relations Service. The coordinating unit in implementing this agreement from Sciences Po Toulouse will be the International Office.

10. Termination

Given that this agreement represents a totally voluntary endeavour by both parties, it may be amended by the mutual agreement of both parties or it may be terminated by either upon prior notification in writing to the other party of not less than nine (9) months. Any termination of this agreement must consider any pending exchange of faculty or students.

The present agreement is established in 2 copies.
